The ACA Prize is the successor of the famous Dr. Kausch-Prize of the Fritz Carl Wilhelm Foundation, which has been awarded annually to highly distinguished accounting academics between 1984 and 2016.

# Program

A distinctive feature of the Symposium are parallel sessions that will be moderated by both an expert from academia and practice. By that the Symposium allows a unique opportunity to bring together both academics and practitioners to discuss their views on a specific topic. In addition, there will be several panels with key-note speakers also both from academia and practice.

On Wednesday evening, participants are invited to a Swiss Apéro reception. The ACA Prize Ceremony will take place in the late afternoon on Thursday. After the last concurrent session, the winner of the best paper award will be announced. The Symposium will close with a joint lunch on Friday.


